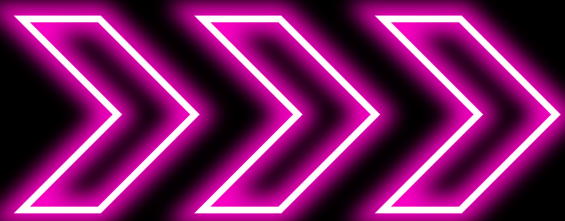

A tailored format built around your audience, objectives and brand experience—delivered in-person, virtual or hybrid. Ideal when you need something more customised than a standard package (e.g., private breakfast, briefing, or partner co-hosted event).

(How it works)



01

ICP-aligned delegate acquisition + seniority gating

We build the guest list around your agreed ideal customer profile, targeting the right job titles, company types, and seniority. Every attendee is qualified to ensure relevance and buying influence.

02

Client sign-off before confirmation

You review the proposed delegate list before final confirmations are issued. This ensures the room matches your priorities and avoids wasted conversations.

03

Rejections allowed only if outside ICP or direct competitor

To protect delivery quality, rejections are limited to clear ICP mismatch or direct competitive conflict. This keeps the process controlled and prevents over-filtering that harms attendance.

04

End-to-end event management and delivery

We manage the full event lifecycle—from planning and outreach to confirmations, guest comms, and on-the-night hosting. You get a premium experience without operational burden.

05

Sponsor attendance included (2–3 reps + moderator depending on size)

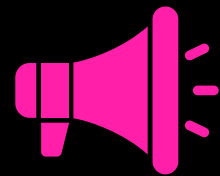
Your team attends with the right structure for natural conversation (not “selling from the front”). A professional moderator keeps discussion flowing and ensures balanced contribution.

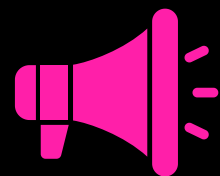

Virtual Roundtable

(How it works)

01

Sponsor attendance (2 executives)

Two sponsor representatives attend the session to engage directly in discussion and build relationships with the right senior audience—without it feeling like a sales pitch.

02

Hosted, moderated discussion (up to 90 minutes)

A professional moderator runs the session end-to-end, keeping the conversation structured, balanced, and outcome-led while ensuring strong engagement throughout.

03

Guaranteed delegate package size (6 / 10 / 12)

You choose the package that matches your objective and budget, with a clear minimum delegate commitment aligned to the agreed seniority level and ICP.

04

ICP-led audience build + seniority gating

We build the audience around your ideal customer profile, targeting the right job titles, company types, and buying influence—so the discussion stays commercially relevant.

05

Client sign-off before confirmation

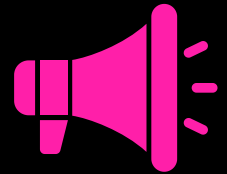

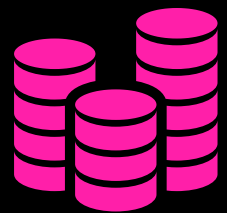

01

ICP-Targeted Outreach & Registration Management

We promote the session to an audience built around your agreed ideal customer profile. We manage registrations end-to-end to keep the process smooth and controlled.

02

Senior Manager+ Audience Focus

Attendees are targeted at Senior Manager level and above, aligned to your ICP. This keeps the session commercially relevant and avoids low-quality registrations.

03

Moderator-Led Delivery

A professional moderator runs the session to maintain flow, engagement, and timing. This ensures the discussion stays structured and valuable for attendees and sponsors.

04

Speaker Management & Preparation

We support speaker prep, session structure, and run-of-show. This improves delivery quality and keeps messaging consistent and on-brand.

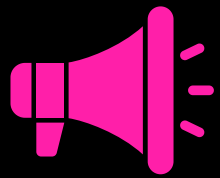

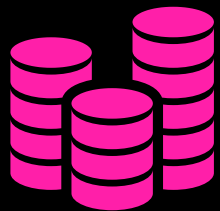
A replay link is provided after the session for continued value beyond the live event. This supports internal sharing, follow-up touchpoints, and content reuse.

- Safeguards + contingencies included contractually (attendance and delivery protections)

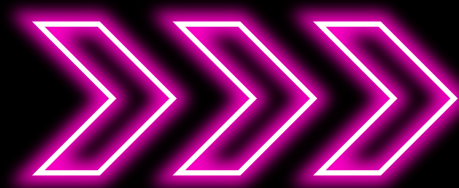
